CHAMBER COMMITTEES

There are multiple committees that are run by, or in partnership, with the Chamber. By becoming a member, you have the opportunity to be an active participant in them and have your voice heard! Below are quick snapshots of each of the committees, what they do, and who to contact if you interested in becoming a committee member.

Chamber Board of Directors

An elected board of 9 Chamber Members lead the Prineville-Crook County Chamber of Commerce. The board makes decisions for the Chamber regarding policy, establishes an annual budget and program of work, elects the offices of the Chamber, and hires the executive director.

Fellow board members vote the 4 officer positions on the board annually. The officers of the Chamber have specific responsibilities but are no more powerful or responsible than any other board member. The officers collectively form the Executive Committee, which coordinates the board agenda and the work of the committees and establishes interim policy for the Chamber between meetings of the board. The officers of the Chamber include the President, Vice President, Treasurer, and the Executive Director.

Ambassador Committee

Chamber Ambassadors are members who volunteer their time to provide a crucial link between the Chamber and its members. They also aid in identifying and recruiting new membership, mentoring newly joined members, and being the key attendees at member events. There are a few requirements to being an Ambassador, such as making a one-year commitment to the committee, consistent attendance at the monthly meetings, attending the Chamber events, participating in the Ambassador Committee projects, and help with the recruitment of new Chamber members and Ambassadors.

Prineville Business Group

The Prineville Business Group is run in conjunction with the Chamber. This committee invites all local merchants, business owners, managers and employees to their meetings every month to discuss upcoming events, news, marketing opportunities, etc. This group has a special focus on sharing good business "kudos," and what is working positively within the attendee's businesses, as well as the Annual Candy Crawl (see "Events" section).

Prineville Creative Exchange

The Prineville Creative Exchange business group focus is to give creative business owners the opportunity to network, collaborate, and grow as business owners and valuable creatives in the community. Many of the attendees are home based businesses, and "makers". This group meets in the evenings to accommodate those who have other jobs during the day. Any community member is welcome to attend, and Chamber membership is not required.

Economic Development of Central Oregon (EDCO) partnership

Rather than being an actual committee, the relationship between the Economic Development of Central Oregon (EDCO) and the Chamber resembles more of a close partnership. EDCO covers all of the communities in Central Oregon, with the goal to "To lead the region's economic and business development through effective marketing, recruitment, retention/expansion, formation of public/private partnerships and fostering entrepreneurship." The Prineville chapter works closely with the Chamber to apply that Mission Statement locally.

CHAMBER EVENTS

The Prineville-Crook County Chamber of Commerce puts on monthly events for members, organizes larger community-wide events, and sometimes helps with other events outside of the Chamber jurisdiction. Listed below are strictly Chamber-involved events, complete with a snapshot summary. Ground Breaking/Ribbon Cutting

We encourage new businesses, businesses celebrating anniversaries, remodels, a new location, and those under new ownership that are members to contact us. That way, not only can we advertise your change and update your information, but we can schedule a Ground Breaking/Ribbon Cutting/Grande Re-Opening Ceremony for you. Often, this event occurs in conjunction with another, such as the After Hours or even the Chamber Perk.

Business After Hours

The After Hours is an event that happens monthly or bi-monthly depending on schedules that encourages business networking in a social, casual, and fun atmosphere. Often, After Hours are planned to coincide with a Ribbon Cutting or other landmark occasion for

the business hosting the event. Any member business can host an After Hours, and since they typically take place in the evening, the host provides finger foods and beverages. Also, members bring their business cards to be entered into a drawing, of which the prize is supplied by the host. (Please note, if you wish to serve alcohol, it may only be served to members and guests of members that are of age.

Chamber Perk

Prineville Perk events are held every Friday from 8am to 8:30am. This event is short, sweet, and to the point. Every week the event is hosted by a different business. The host provides coffee, breakfast finger foods, and a prize to be won by a business card drawing. To begin with, the host is given the floor to introduce themselves, and talk about what they do. Then there are introductions around the room. After which, if anyone needs to make any announcements regarding special sales, events, or happenings around town, they are made. This is also a good time to get in touch with the Chamber staff to verify dates for upcoming events, and to get yours added to the calendar. It's a wonderful jump-start to the last day before your weekend!

Annual Awards Ceremony & Banquet

The Annual Awards Ceremony takes place every year on the spring. It is a fundraiser for the Chamber of Commerce. The banquet is great event that gives the Chamber, and the community, a chance to honor outstanding Members! Every year we award "Large Business of the Year," "Small Business of the Year," "Citizen of the Year," "Visual Enhancement," and more! The banquet is themed and dressing up in HIGHLY encouraged! It is a fun and lively event for all!

Stampede Street Party

The Stampede Street Party kicks off the Crooked River Roundup and comes right before the Fourth of July. Those two week are some of the busiest and biggest times of the year in Prineville. The Crooked River Round Up is always the last weekend in June, and while we are not in charge of it, we do throw an amazing street party to kick things off with a cattle drive, chili feed, live band and more. During Independence Day, we help put on an event for the whole community! You can expect a parade, live music, vendors, lots of food and various contests!

Annual Lighted Christmas Parade

A Crook County tradition, the Lighted Christmas Parade happens on or around Thanksgiving weekend and consists of a festive line up of parade floats creatively adorned with the lights, colors, & sounds of the holiday season. Usually the Lighted Christmas Parade coincides with the beginning of other festive holiday events and traditions throughout Crook County, including Christmas In The Pines.

CHAMBER PUBLICATIONS & COMMUNICATIONS

The Chamber puts out one publication, weekly email correspondence, a comprehensive community calendar, and hosts a robust Facebook page and Instagram feed. There are several advertising and promotional opportunities for members through several of these communications platforms.

Weekly Email Updates

Weekly Updates go out via email. Chamber staff sends out these emails every week, typically on Tuesdays and Thursdays. They offer a heads-up snapshot of the week ahead, giving important meeting dates, times, location, and contact information.

We offer businesses to have a display ad in the weekly email, above where our calendar information is listed. The charge for this is \$75/mo or \$25/week.

At the bottom of our email, we include "Member Flyers" which highlights event info, sales, etc. as attached documents for FREE! There is no cost to members for information placed in the "Member Flyers" section of our email communication.

With over 2,900 likes on our Facebook page, we try to share as much as we can on our page. We can promote any event, sale, or news that our members have on our page. It is free to all members, and is a fun, fast, popular, way to get information out to the community.
