

# **Official Rules: Prineville Crook County Chamber and Visitor Center Weekend Getaway Sweepstake Rules**

## **AGREEMENT TO RULES:**

Participation in the Prineville Crook County Chamber and Visitor Center Weekend Getaway Sweepstake Sweepstakes (“Sweepstakes”) constitutes your full and unconditional agreement to and acceptance of these Official Rules and the decisions of Prineville Crook County Chamber and Visitor Center (“Sponsor”), which are final and binding.

## **ELIGIBILITY AND RESTRICTIONS:**

Sweepstakes is open to people 21 years of age or older who are legal residents of the 50 United States and District of Columbia, except where prohibited by law. Sweepstakes is subject to all federal, state and local laws and regulations and is void outside of the 50 United States and the District of Columbia and where prohibited by law. Sponsor is not responsible for typographical or printing errors, lost, late, damaged, undeliverable or misdirected entries or postage-due mail. Entry forms distributed where prohibited by law, or not obtained lawfully, will be null and void. All entries become the exclusive property of Sponsor and will not be returned. Winners will be notified by email. Any use of robotic, automatic, macro, programmed, third party, or like entry methods, will disqualify all entries using such methods.
